The seller ("Sedona"), by accepting a deposit amount specified above, agrees to hold the puppy for the buyer until release time. The deposit is a non-refundable deposit that will be subtracted from the total sale price. This deposit signifies the intent on the part of the Buyer to follow through with the Purchase of this Puppy. No puppy will be held for any individual before a deposit is received.

Once the puppy has received its first vaccinations and passed a full health check a pick up date for the puppy will be agreed and you will be required to pay the remaining amount prior or at the time of pickup.

If the puppy is found to be ill or unhealthy or for any reason does not pass the Veterinary Health check (that all puppies will receive before leaving for their new homes) a full refund of all monies paid or replacement puppy will be offered to the buyer.

Sedona reserves the right to refuse/cancel sale at any time. If Sedona chooses to void the sales transaction for their own reasons a refund of the deposit will be provided.

All puppies will be de-sexed prior to leaving Sedona, no exceptions.

The subject puppy, to the best of Sedona's knowledge, is in good health and free of communicable diseases at time of sale. The puppy will have had a full health check, first vaccination, be micro-chipped and wormed before being released to buyer.

If in the case the puppy is to be held with the Sedona for an extended period after puppy is old enough to leave, due to buyers request, the buyer understands that they will be accountable for veterinary costs for the 2nd vaccination if due while still in the care of Sedona.

It is recommended that a licensed veterinarian examine the dog during the first 72 hours from purchase. A full refund or a replacement dog when one becomes available will be given for any dog found unhealthy or unsatisfactory during the first 72 hours. Your veterinarian's written statement of diagnosis, including a detailed description of all symptoms supporting that diagnosis, results of any tests performed, and the reason why he/she feels the dog is a poor health risk must be presented at the time the dog is returned. If the Buyer does not take the dog for a check-up within 72 hours from the date of purchase, this warranty becomes null and void.

Sedona hold no responsibility for the development of diseases or health conditions that can be caused by the environment, lifestyle, diet and/or improper care of the dog. We do not provide any guarantee on quality of coat.

It is recommended that the buyer research the dachshund breed prior to purchasing a puppy. Sedona will not be held responsible for lack of education.

Please ensure this is the right puppy for you. We **will** take your puppy back if you no longer want it. But Sedona do not guarantee any refund of money to the buyer for returned puppies. We will consider your circumstances but make no commitment to a refund.

THE BUYER AGREES AS FOLLOWS:

1. The Buyer will provide a safe and healthy home for this dog.
2. That Buyer will have this dog vaccinated and seen by a veterinarian on a regular schedule and ensure that the dog receives good medical treatment and care.
3. That Buyer is responsible for all veterinarian fees for the examination and/or treatment of the dog.
5. That UNDER NO CIRCUMSTANCES will Buyer ever turn the dog over to a shelter or RSPCA or abandon the dog. If you cannot provide a safe and healthy home, you are to return the dog to Sedona. Furthermore, Sedona will not be liable for any refund of the Total Sale Price.
6. Buyer agrees to have the puppy de-sexed before it leaves the premises of Sedona.

Special Provisions:

Buyer acknowledges that this written Agreement constitutes the entire Agreement regarding the health, condition, care and loss of the dog between the Buyer and Sedona and that he/she has relied on no oral representation contrary to this Agreement.
